1. Business Domain View

1.1. Problem Statement / Business Need

The Council of the European Union issued Council Directive 2001/115/EC of 20 December 2001 amending Directive 77/388/EEC with a view to simplifying, modernising and harmonising the conditions laid down for invoicing in respect of value added tax. This directive created a need to develop an extension of the existing invoicing standards for European Union countries to implement these requirements.

1.2. Objective

To supply the detail design of the EU VAT business transaction needed to meet the requirements of the Invoice-European Union Value Added Tax (VAT) Extension BRAD.

1.3. Audience

The audience of the standards would be any participant in the global supply chain specifically European Union Trading Partners

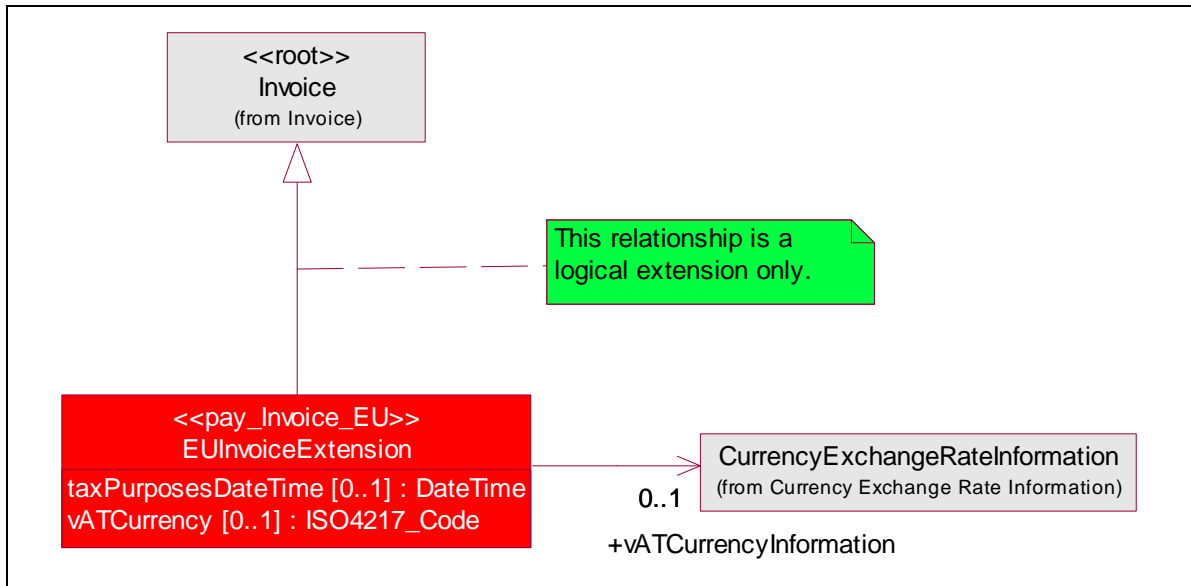

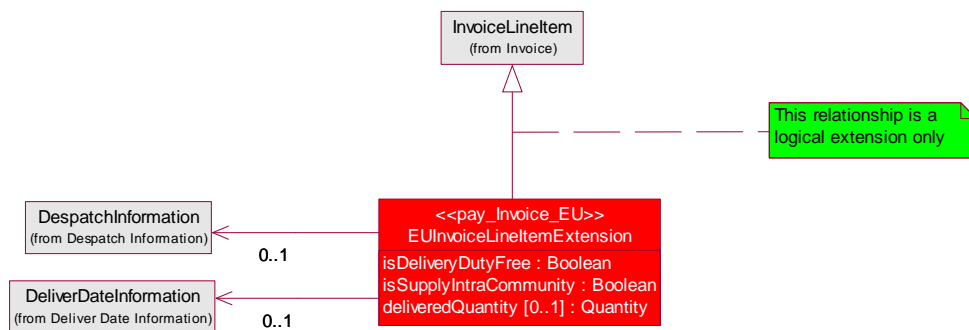
